## TAIAO INCIDENT REPORT FORM P2

TAIAO rules specify that when a player or coach is ejected from a contest, that player or coach, at a minimum, becomes ineligible for the next contest. A second ejection in the same season results in a two game suspension, and a third ejection by the same person results in suspension for the remainder of the season. Furthermore, if an organization has a total of 3 player/coach ejections in a season, a member of the organization will be required to have a meeting with the appropriate committee chair. Please complete the remainder of this form to accept or appeal this minimum sanction.
