



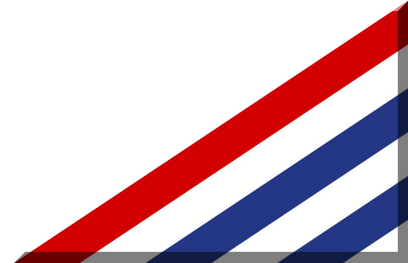

# Sports Plans

- Every sport now has a sports plan ([View Plans](#))
- Committees make suggestions to Commissioner on changes \*\*
- What sports plans do not govern
  - Athlete Eligibility
  - Rosters and transfers
  - General rules infractions
  - Postseason event management (facilities, officials, gate, etc.)
- Primary purpose of committees & plans
  - Creation of divisions
  - Seeding of postseason
  - Coaching and player infractions
  - Adjudicating sport specific rules & regulations
  - All Stars selection and participation



# Changes to General Rules

## **CREATION OF COMPETITIVE DIVISION**

- Expands D1 & D2 to create “Competitive Division”
- More than 50% club players AND/OR 20% or more games v D3-D6 teams
- Every team submits rosters provided by TAIAO

## **REQUIREMENT OF FULL ENROLLMENT IN PRIVATE SCHOOL**

- Partially enrolled students or students who have any homeschooling will be treated as homeschoolers for eligibility
- All teams will designate if a student is 1. Homeschooled 2. Partially Homeschooled 3. Not Homeschooled



# Changes to General Rules (continued)

## **ALL TEAMS IN MAXPREPS**

- MaxPreps requirements and clarify that it does not replace TAI AO roster submission
- JV team schedules must be in MaxPreps
- Maxpreps used for seeding postseason / pool play

## **EXPANSION OF PLAY UP RULE**

- Expands the "Play Up" provision to allow 8th graders (age 14 after May 31st) to temporarily join varsity teams due to injuries
- Week by week application
- Adds oversight for misuse of the new rule to ensure compliance.
- Football, Baseball Softball +2
- All other team sports +1



# Changes to General Rules (continued)

## **TAIAO REIMBURSEMENTS**

- Establishes basic reimbursement caps for travel and per diems.
- Provides Commissioner with the authority to amend with SC approval

## **POSTSEASON FORFEITS**

- Removed monetary fines as a disciplinary option
- Introduces the automatic postseason disqualification for the next season following a forfeit
- Allows an appeal mechanism to the Steering Committee

## **COACHES EXEMPTIONS FOR TRANSFERRING TO NEW TEAMS**

- Allows only two coach-related athlete exemptions per organization.
